WWE superstar John Cena files for divorce; wife hires Miami attorney



Tampa resident and WWE superstar **John Cena** has filed for divorce from his high school sweetheart and wife of only 3 years, **Liz Huberdeau**, saying the marriage is "irretrevably broken." The soon-to-be-ex-Mrs.Cena has armed herself with powerful Miami attorney **Raymond Rafool**, best known for going head to head with **Hulk Hogan** in his nasty divorce battle against ex-wife Linda.
